

- (e) The supply of the 02 (two) nos. Toyota Dyna Dead Body Freezing Van to be completed within 120 days from the date of signing Contract in the 2019-20 financial Year.

You are requested to proceed with the supply of the Toyota Dyna Dead Body Freezing Van and the related services; and note that this Notification of Award shall constitute the formation of a Contract Agreement (Form PG3-10), which shall only become binding upon you furnishing 10% Performance Security (Form PG3-11) within 14 days, in accordance with ITT Clause 63.2 and the signing of the Contract Agreement within 28 days, in accordance with ITT Clause 66.2.
